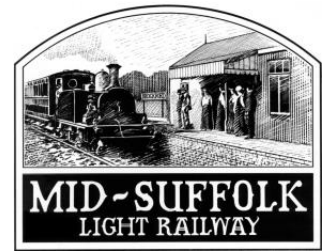

### Conditions of Entry

1. Trains will be in operation during the day and exhibitors, like visitors, must follow the railway safety rules, in particular keeping only to public areas. In no circumstances should any exhibitor walk on the railway track.
2. All exhibitors must be insured against third party risks, if appropriate to the attraction concerned. If you require public liability insurance, you must have sufficient cover to attend this event and meet current requirements in regards to de-activated weapons.
3. All participants to the Middy in the War Years events are also advised: *Following the guidelines outlined by the Heritage Railway Association, the Middy will not permit access to visitors or re-enactors who are attired as Schutzstaffel staff, Allgemeine SS forces, Waffen-SS or who wear any uniform or clothing displaying the Totenkopf (Deaths' Head) symbol, red armbands emblazoned with the swastika or any other overt Nazi insignia.*

### Vehicle Exhibits

1. Only vehicles dated pre 1950 will be allowed in the vehicle display areas.
2. All vehicles must be insured against third party risks and fully licensed and tested in accordance with the regulations applicable to that type of vehicle for road use. The organisers reserve the right to ask for proof of these items.
3. Owners must ensure that all drivers are qualified in law to handle the class of vehicle exhibited.
4. No exhibit shall be left running unattended. All unattended vehicles shall be left securely braked and/or chocked.
